In reference to the CCH's letter No. F.No.15-5/2017- CCH(37)/ 10086-10089 dated 03.08.2018 wherein a Letter of Intent was issued to the Secretary, Sou. Devibai Narayandas Chhabada Rural Education Society, Satara to start a New Homoeopathic Medical College in the name and style of Mahalaxmi Homeopathic Medical College and Hospital and Research Centre, Maharashtra with 60 seats in BHMS course from the academic session 2018-19 subject to fulfillment of certain conditions, I am directed to say that after careful consideration of your proposal in terms of the provision of the HCC Act 1973, relevant regulations, inspection report of the CCH and report of the designated hearing committee of this Ministry; permission of the Central Government is hereby granted to **Secretary, Sou. Devibai Narayandas Chhabada Rural Education Society, Satara to start a New Homoeopathic Medical College in the name and style of “Mahalaxmi Homeopathic Medical College and Hospital and Research Centre”, Maharashtra with 60 seats in BHMS course from the academic session 2018-19** under the provision of the section 12A of the HCC Act 1973.

2. The college administration will ensure that sufficient qualified teaching faculty, non-teaching staff, hospital staff and other requirements as per the provision of HCC (MSR), 2013; Regulations are in position before the admission of the first batch of students in the 1<sup>st</sup> professional BHMS course is made, under intimation to the Central Government and CCH.

3. The college has to develop the requisite infrastructure for 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> BHMS course well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.

4. The college administration may take up the matter for recognition of the qualification under section 13(1) of the HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.


