The Account shall be kept in a bound book, paged and stamped with the seal of the Collector [or the Mamlatdar or Tahsildar] or the Mahalkari or any other officer autiforised in that behalf by the Collector]

(2) The licensee[other than the one who has obtained an order of exemption under rule 16-B of the Bombay Rectified Spirit Rules, 1951], shall keep along with the account book, the requisitions and transport passes relating to the spirit received at the licensed premises.
